### Article I:

I am an American, fighting in the forces which guard my country and our way of life. I am prepared to give my life in their defense.

#### Article II:

I will never surrender of my own free will. If in command, I will never surrender the members of my command while they still have the means to resist.

# Article III:

If I am captured I will continue to resist by all means available. I will make every effort to escape and aid others to escape. I will accept neither parole nor special favors from the enemy.

## Article IV:

If I become a prisoner of war, I will keep faith with my fellow prisoners. I will give no information or take part in any action which might be harmful to my comrades.

If I am senior, I will take command. If not, I will obey the lawful orders of those appointed over me and will back them up in every way.

## Article V:

When questioned, should I become a prisoner of war, I am required to give name, rank, service number and date of birth. I will evade answering further questions to the utmost of my ability. I will make no oral or written statements disloyal to my country and its allies or harmful to their cause.

# Article VI:

I will never forget that I am an American, fighting for freedom, responsible for my actions, and dedicated to the principles which made my country free. I will trust in my God and in the United States of America.

My name is Catherine Arnett. I am a Lance Corporal in the United States Marine Corps. My service number is 1546130599. My date of birth is March 24, 1998.

If you are reading this letter, it means I have been transferred/am being transferred from Okinawa, Japan to California, United States of America. My home duty station is MCAS Iwakuni. I was sent to the Camp Hansen Brig on January 23, 2023 for petty charges that reflect retaliation for not receiving the COVID-19 vaccine. This is unconstitutional, unlawful, and entirely illegal. My Oath of Enlistment requires that I defend the Constitution against all enemies, foreign and domestic. The leaders and people who have imprisoned me have been acting entirely contrary to the values of the Constitution that we hold dear as a country and that are afforded to members of the civilian populace and the Armed Forces as well. My leaders have deliberately withheld justice and lawful action and allowances from me. I have been compromised in my location and I am now facing more illegal action, up to and included being escorted off and barred from this base without actual and proper due process. I am concerned for my well-being, up to and including my life and my safety not being taken into consideration in these events. If you are any entity involved in this transfer, you are aiding unlawful and subterfuge personnel mismanagement and assisting the leaders in carrying out additional unlawful actions.

I fully and consciously and willingly declare that upon the moment I am taken into custody by military police (or other entities) to be transferred from Okinawa to California/CONUS, I will not speak, I will not eat, and I will not consume any drink until I am permitted to speak to General David H. Berger.

I request immediate recourse to be able to talk to the Commandant of the Marine Corps in order to voice my concerns and seek resolution to these unlawful happenings that have been taking place for the entire last 2 years.

I have Requested Mast about 10 times if not more, to this day, about these entirely unlawful happenings and I have been denied every time. I have been silenced, stifled, and kicked around by the leaders appointed above me who are supposed to be assisting me in my Oath of Enlistment and upholding those values as well. I have not been assisted and I have experienced massive amounts of retalliation and abuse for these things.

I have provided everything that is required of me, as I am now in captivity on my own nation's soil.

I have been found competent by the naval psychiatrist aboard MCAS Iwakuni prior to imprisonment and the military judge stated on the record he found me competent in order to conduct my defense in my upcoming court martial. I pose no threat to the safety of anyone or any entity.

To everyone whom reads this letter, you are, either knowingly or unknowingly, aiding and abetting in breaches of contract and other violations of law, statute, and policy. My life is in your hands and I patiently and hopefully await recourse.

I have printed and signed multiple copies of this letter in order that every entity is given this information, and I request that these papers stay on my person at all times.
